CALL REGULAR MEETING TO ORDER - 7:00PM - Pledge of Allegiance

APPROVE AGENDA – <u>A MOTION</u> to approve the agenda as presented was made, seconded, and carried.

MINUTES - A **MOTION** to approve the minutes from the April 13, 2022 regular meeting and Public Hearings was made, seconded and carried.

AUDIENCE

Nelson Engineering – Matt Bowers with Nelson Engineering was present to discuss repairs to Cell #3 at the Wastewater Treatment Plant and a possible diffused air bubbler system. The existing, working liners are failing and the patches in Cell #3 may fail. After a site visit to the plant, Matt provided a rough overview for possible repairs. Several replacement/repair options and cost estimates were provided. Matt stated the cost of materials overall have increased at least 50%. Currently, the treatment process is aeration which causes four motors and draft tubes to be replaced per year with repair costs being high. Public Works asked Matt to research a possible diffused air bubbler system that diffuses air in the bottom, with no surface issues. A cursory review was conducted by the engineer with Matt's recommendation being more research being conducted into the new system due to costs and funding sources such as Green Energy Grants due to the decreased energy costs. To make repairs to the existing system, Mineral Royalty monies can be applied for. Matt's recommendation is, at a minimum, to repair/replace the existing towers. Several options were discussed regarding a possible new system with Matt again recommending more analyses be conducted.
