

# COUNTY 10 RADIO'S 'PICK-A-TICKET'

## Contest Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

### 1. HOW TO ENTER

- a. The County 10 Radio 'Pick-a-Ticket' contest will begin on May10th, 2023 and end on May16th, 2023
- b. To participate in the Contest, you may enter via the following method(s): (1) Website - listeners on 97.5 The Brand and/or 105.1 JACK FM will be directed to county10.com to fill out a form to be entered into the random drawing.
- c. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning the email address or the domain associated with the submitted email address.
- d. The Station is not responsible for entries not received due to missed call, difficulty understanding caller, difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches. The Station is not responsible for, illegible, incomplete or late entries. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.

### 2. ELIGIBILITY RESTRICTIONS

a. The Contest is open to all persons who are **18** years of age or older and who reside in Fremont County, WY. Employees and freelance contractors of **KTUG, KDLY, and KOVE** (the "Station(s)"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in Fremont County, WY and the members of their immediate families **AND/OR HOUSEHOLDS** are ineligible to participate or win. The Contest is subject to all applicable federal, state and local laws and regulations.

- b. Participants can only win once during this contesting period.
- c. **Participants must sign any and all Station waivers, rules and release forms before accepting prize.**
- d. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

### 3. PRIZES

- a. 2 tickets or one pair of concert ticket(s) will be given each time a winner is chosen. Concert tickets will be determined by the winner's answer to the form question, "Which concert are you wanting tickets to?".

- b. All prizes or prize certificates may be picked up at the office of the Station at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of Station management with respect to the contest are final.
- b. Participant's will be contacted via their phone number given on entry form, and if not reached will be sent an email. Tickets are received via email.
- c. **ODDS OF WINNING DEPEND UPON THE NUMBER OF ENTRIES RECEIVED, AS APPLICABLE.**
- d. Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the Contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.

The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station's Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
